

ORDINANCE NO. 81-3


AN ORDINANCE ESTABLISHING RULES AND PROCEDURES FOR THE UPCOMING 1981 MUNICIPAL ELECTIONS ACCORDING TO THE LAWS OF THE STATE OF UTAH.

WHEREFORE, it has been deemed reasonable and prudent by the Town Board of Wendover, Utah, that in order to properly conduct the 1981 Municipal Elections of the Town of Wendover, Utah, the following rules and procedures are hereby mandated:


1. That there shall be no primary elections in the Town of Wendover, Utah for the 1981 Municipal Elections.
2. That those persons who desire to convene and designate their party nominations must do so on or before the 5th day of October, 1981.
3. That on or before the 9th day of October, 1981, each and every person desiring to run for public office must file a Declaration of Candidacy with Wendover Town Clerk.
4. That each and every person who does file a Declaration of Candidacy will be placed on the General Election Ballot, even though they may not have been nominated by a party convention.
5. That the Official General Election Ballot shall not designate any party or group affiliation with any of the candidates.
6. That the General Election for municipal offices in the Town of Wendover shall be November 3, 1981.

WHEREFORE, due to the extreme short length of time before the General Election and due to the necessity to inform the general public of the above rules and procedures, it is hereby ordered that this Ordinance be enacted and become effective upon passage.
