

ORDINANCE # 83-27

AN ORDINANCE MAKING IT ILLEGAL TO PERMIT A VEHICLE TO DRIVE OVER A FIRE HOSE

WHEREAS: The City Council have deemed it reasonable and prudent and in the public's best interest to protect Firemen, Fire Equipment ^{AND} public and private property.

WHEREAS: Therefore, the Wendover City Council has voted unanimously to make it a criminal offense for any person, at anytime, to drive over a firehose, be it full of water or not.

THEREFORE, Any person who drives over a firehose, at any time, irregardless of whether the firehose has water in it or not is guilty of a Class "B" misdemeanor.

THIS ORDINANCE TO BECOME EFFECTIVE THIRTY(30) DAYS AFTER POSTING IN THREE(3) PUBLIC PLACES.

AMENDMENT TO ORDINANCE #80-8 BY CHANGING THE ZONING MAP OF THE CITY OF WENDOVER

WHEREAS: The City Council of the City of Wendover, has deemed it necessary in order to promote and protect the Health, Safety and Welfare of the Citizens of the City of Wendover, that the Wendover Zoning Ordinance be amended as follows: That the City Zoning Map be changed as follows:

PARCEL BELONGING TO STATELINE PROPS. LOT 1, BLOCK 13. DESCRIPTION AS FOLLOWS:

#1- Beginning at the Southwest Corner of Lot 1, Block 13, Wendover Plat "A" and running thence N 64°15'00" E 250.89 feet; thence S 25°45'00" E 67.23 feet; thence S 64°02'00" W 270.549 feet to the East Line of "A" Street; thence N 09°41'00" W 71.027 feet to the point of beginning. Contains 17,656 sq. feet. TO BE CHANGED FROM AN R-3 TO C-2 ZONE.

#2- Beginning at a point on the East Line of "A" Street S 09°41'00" E 71.027 feet from the Southwest corner of Lot 1, Block 13, Wendover Plat "A" and running thence N 64°02'00" E 270.549 feet; thence S 25°45'00" E 84.40 feet; thence S 64°15'00" W 294.56 feet to the East Line of "A" Street; thence N 09°41'00" W 86.766 feet to the point of beginning. Contains 23,697 sq. ft. TO BE CHANGED FROM AN R-3 Zone to a C-2 Zone.

EFFECTIVE DATE: This ordinance shall become effective thirty(30)days after the date of passage and after having been so posted in three(3)public places in the City of Wendover, Utah.


