

ORDINANCE NO. 2006-05

**AN ORDINANCE EXTENDING TEMPORARY RESTRICTIONS
OF OFF PREMISE OUTDOOR ADVERTISING SIGNS IN THE
CITY OF WENDOVER, UTAH**

RECITALS

A. The City adopted Ordinance no. 2006-02 on February 01, 2006 and said ordinance became effective on the date of posting, March 22, 2006.

B. Ordinance 2006-04 extended the restrictions on off premise outdoor advertising to September 22, 2006.

C. The City desires to extend said moratorium through 60 days from the effective date beginning October 04, 2006.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WENDOVER,
UTAH AS FOLLOWS:

Section 1. Moratorium Extended. The effective date of Ordinance no. 2006-04 shall continue through December 04, 2006 which date is sixty (60) days from the date said ordinance was posted as required by law. All other provisions of Ordinance no. 2006-04 shall remain in full force and effect through December 04, 2006.




